- a. One workshop on data management for data providers
 - **Profile:** Data providers and curators
 - Expected number of participants: 30 40
 - Number of institutions: 15 20
 - General affiliation:
 - Biological collections (Individual collections, Networks and Associations, such as the National Botanical Gardens Network secretariat- and the National Herbaria Association)
 - Research Centers and Institutes (Members of SiB Colombia: Ciebreg, Sinchi, Invemar, IAvH, ICN, etc)
 - o NGOs (Omacha, Humedales, Pangea, etc)
 - o Privates (Isagen)
 - O Universities (Javeriana, Andes, Nacional, Antioquia)
 - o Regional Authorities (Corantioquia, Corpochivor, Carder, Corpoamazonia, etc)

All of them are partners of the SiB national process and currently provide raw data through SiB data portal.

- b. One training and hands on session for IT technicians, comprising online publication on DIGIR/Tapir technologies, GBIF infrastructure, and tools for data portals.
 - **Profile:** IT technicians
 - Expected number of participants: 6 -10
 - Number of institutions: 6 10
 - General affiliation:
 - One or two biological collections (at ICN and Invemar)
 - o Universities (Javeriana, Andes and Nacional)

- Research Centers and Institutes (Invemar, Ideam, IAvH and Sinchi; perhaps Ciebreg and IBUN).
- o Privates (Isagen)
- Thematic and Regional Information Initiatives (CHM, BCH, Siac, Siat-AC, Siat-PC)
- 2. Ensure that the "train the trainers" approach will be applied in developing these workshops/training sessions. Indicate whether there are any plans to replicate these training activities involving other institutions within the country or abroad.
- The Biodiversity Information System of Colombia Network is a real institutional network that works in a membership schema. This model, created for the improvement of information management skills in the country, ask us to develop many capacity building activities with our partners, many of them in a profile of "Multipliers", meaning that their role for the implementation of the System in Colombia is not only improving and sharing their information, but helping others to apply the biodiversity information management tools.
- In that way, the SiB partners and the Humboldt Institute on its coordination role, are familiar with the "train the trainers" model, which will be applied too in these workshops/training sessions.
- Commonly, at the end of the workshop/training session, the SiB Coordinator Team and the partners/participants, draw a replication plan considering the budget issues, in order to obtain the required funds for the new training sessions with others at the regional or thematic level.
- In this opportunity, we can use the same approach to guarantee the replication within the Country, and abroad, considering the Mentoring Proposal with Argentina.
